## **Photography & Filming Consent Form**



Consent Form for Rochdale Company of Archers.

In accordance with the Archery GB Safeguarding Children and Young People Policy, we wish to inform you of RCA's photography policy which follows the guidance in The Archery GB Guidance Document (SCG 05) Photographing/Videoing Children and Young People in Sport; a copy of this is on the club noticeboard.

Parents/carers should be aware that it is highly likely that photographs will be taken at RCA events such as social occasions like the Christmas party or at club shoots.

These will often be published on the club's Facebook page and/or website. Young people will not be named if these are photographs of individuals. They may be named by first name only if they are part of a group but will not be referred to specifically.

Photographs of children/young people will only be taken/used if they are in suitable dress and show a positive image.

Images will only be stored for as long as is necessary, for the purpose for which they have been taken and then will be deleted. Reasonable care will be taken to ensure they are stored securely.

If parents/carers do not wish for photographs of their child to be taken in a specific situation, they should inform the photographer and/or the organiser of the club event.

If parents/junior archers have concerns about images being taken they should report this to a club official. If images are deemed inappropriate or there are concerns that images are being used inappropriately, this should be recorded on a safeguarding incident form and passed to a club official/safeguarding officer immediately.

Coaches may sometimes use video recording as a training aid. They will only use these recordings for a limited time duration, after which they will be deleted. Parents/carers will usually be consulted before these recordings are made.

Parents or other Juniors will agree to not publish photographs of other people's children on public media sites such as Facebook without the consent of both the child and the parent. They should also not name any child in a way in which it makes them identifiable in a published photograph, through the comments they may add to such a site.
